EXECUTIVE SUMMARY

The smart city proposal of Kochi submitted for Smart Cities Challenges aims at integrating the Fort Kochi & Mattancherry area with Central City Area through Water Metro. Thematic areas for interventions under smart cities mission in Kochi are

- Seamless Mobility
- Reconstitution of Urban Form
- World Class Urban Services & Inclusive Development
- Revival of Identity and Culture

The Smart City proposal of Kochi has adopted retrofitting as the strategy for development under the Mission. The vision for Kochi is to transform Kochi, into a sustainable, inclusive and economically vibrant city of opportunities with efficient urban services, traditional hospitality and smart governance.

a) Area Based Development (ABD) projects

There are 71 ABD area projects under 18 modules worth a total cost of Rs. 1362.01 Crores. Area Based Development (ABD) as part of Smart City development consists of parts of five wards west Kochi (1,2,3,4 and 5) and parts of three wards of mainland of KMC (62,66 & 67), with a total area of 1024.16 acres. 






Figure 1-8 Bridges across canals at West Kochi

1.3 BRIEF SUMMARY OF MEETINGS

1. Review meeting: Smart Cities Mission - Kochi, chaired by the honourable Mayor, Kochi Municipal Corporation held on 6th February 2019 at 10:30 am

A review meeting were held for the review of projects under Kochi Smart City Mission, chaired by Hon'ble Mayor, Smt. Soumini Jian. She welcome all the invited guests including ward councillors, standing committee chairpersons, Kerala Merchants' Chamber of Commerce (KMCC), Ernakulam Market stall owners Association (EMSOA) representatives etc. and CSML officials. The discussion aimed at collecting opinions regarding project proposal and assistance required from KMC to implement the identified projects

- a) Ernakulam Market: Detail discussion were held on the proposal of Ernakulam Market. Following broad suggestions were given:
- KMCC members mentioned that at present, excluding fish/ poultry section, 216 stalls
 are there with 212 at ground and 4 at first floor. Among them only 10- 12 shops sell
 stationary goods. As rest of the shops deal with perishable goods and hence it is not
 advisable taking them to first floor.
 - Smart City team clarified that these new floors are facilitated with goods lift, ramp access, etc and hence mobility would not be an issue. Also considering the municipal regulations, it is not possible to fit every stall on the ground floor as it is happening currently.
- Provision for simultaneous multiple loading and unloading activities needs be provided.
 Smart City team clarified that already there is provision for about 6 trucks to be parked at a time without disturbing the road and pedestrian activity, and there is scope for more truck parking bays in proposal.
- Lack of Hygiene- most important issue faced by the market- Hence, segregated provisions for poultry and fish to be considered while planning of shops. Smart City



team confirmed to make provision for ensuring sanitation in the area with support of authorities.

- Plot for relocation of existing stalls during construction phase is a key task for KMC.
 Smart City team has proposed that a built-up space would be preferred for transit duration in order to same time. The locations proposed for transit shelters for shops were:
 - Marine Drive Ground under GCDA. However, approval for using land allocated as open space will be a challenge.
 - o It was pointed out during the presentation that Muslim school ground proposed for building transit shelters will be slightly less as may be only 75% of the existing stalls might be accommodated. Smart City team clarified that currently there are many spaces wasted in market and an organized layout would fit into an organised smaller space. In terms of moving to new location this ground will be ideal.
 - Space suggested at Kaloor- No space for auction; Very less access for heavy vehicles. This issue shall be reviewed by the Smart City team.
 - Discussion with concerned authorities shall be taken forward as all suggested plots are under the ownership of GCDA or any private authority.
 - Traffic impact after relocation also shall be assessed once the land to be used is confirmed by KMC.
 - Skywalk from Marine Drive to Market may be long walking distance- feasibility of the proposal may be evaluated. Smart City team informed that there would be entry and exit points from skywalk to Shanmugham road & Broadway, hence the skywalk would serve multiple purposes and ease of movement.
- Traffic impact of the development on the adjacent roads will be huge. Parking requirement will be very high which needs to be considered. Smart City team clarified the aim is to promote public transport as the location is well connected with Metro and buses and in future with water metro. Also Parking in GCDA is proposed. KMC to approve the same to support Ernakulam Market redevelopment.
- Car parking provision in the upper levels of market square is an option that can be developed. Smart City team confirmed that this option has been discussed and can be included in proposal.
- As there are no residence nearby, Kuttappayi road can accommodate fish stalls along canal-side. The road is found wide enough to cater the facility. Smart City team clarified that the canal is proposed to be rejuvenated and acts as a recreational open space. Hence is not envisaged for drainage purpose.
- Regarding vendors along canal-side
 - Relocation of vendors along canal also shall be considered.



- KMC to take a final decision on the hawkers and share a list of final eligible hawkers to CSML for including in the proposal.
- Side wall of the canal to be reconstructed; similarly, first two steps can be encroached
 for widening of the road. To which Smart City team replied that the roads are wide
 enough and a proper strategy with organized hawker zone is planned and
 encroachment is not envisaged or promoted.

Decision taken: Smart City Team to Proceed with Tendering to Ernakulam market proposal presented as soon as possible. Final approved list of vendors and hawkers to be shared by KMC with smart city team at the earliest to enable Smart city team to do detailing of the designs.

b) **Broadway Street Upgradation**

The smart city team explained about the proposal to KMCC & KMC that it includes Pedestrianize the Broadway street stretch in a time bound manner from 12.00 pm to 8.00 pm allowing only E-rickshaw & emergency vehicle movement. Pedestrian oriented street with partial canopy covering with regulated vehicular access. Street is proposed as no parking zone.

Assistance required from KMC & KMCC:

Smart city Team requested KMC & KMCC to share final list of eligible hawkers to enable Smart City team to accommodate the licensed hawkers along multi utility zone with cart size requirement. Approval of revised traffic management plan from beneficiaries, Co-ordination with all beneficiaries.

Following broad suggestions were given:

- Improvement plan of by-roads of Broadway such as cloth bazaar road, Jew street may also be included for such upgradation. Redevelopment of Mather bazar to be considered. Smart City team mentioned that some of these are covered under the 'Roads' project. Smart City team also proposed that some of these can be taken up in phase II post implementation of Broadway street upgradation based on fund availability and learnings from implementation of proposal of Broadway Street upgradation.
- At least one-way traffic to be allowed rather than restricting vehicular movement completely considering the loading & unloading requirements of the street. Smart city team clarified that the proposal is only for time bound pedestrianization hence to cater to the businesses the loading and & unloading is proposed before and after pedestrianization timings.
- Designated parking provisions also shall be provided. Smart City team further detailed that MLCPs have been proposed at KTDC plot & GCDA to meet the parking requirements. However, maximum number of visitors visit the market through public transport and auto rickshaws. Hence pick up and drop off facility from these locations by e- vehicles. Hence visitors who currently have to walk from bus stops now will have e-vehicles to drop them.



- Removal of parking facility as well as vehicular movement may critically affect the business of the street. Smart city team again mentioned that maximum number of visitors visit the market through public transport and auto rickshaws. Hence pick up and drop off facility from these locations by e- vehicles. Hence visitors who currently have to walk from bus stops now will have e-vehicles to drop them. Also, Smart city team clarified that this is a flexible proposal. Time bound pedestrianization timings can be changed. But the association may understand that both public and shop keepers are in favour for making the market walking friendly. Only there will be some hindrances that through public consultations all stakeholder should be able to manage.
- Community consultation with shop owners along Broadway can be arranged in the next week itself which was confirmed by KMCC General Secretary Mr. Mohamed Sageer.

Decision taken: Smart City Team to Proceed with Tendering to Broadway Street upgradation proposal presented as soon as possible. Final approved list of hawkers to be shared with smart city team at the earliest to enable Smart city team to do detailing of the designs that include allocation of hawkers in Multi utility zone.

c) Open space corridor linking DH Ground to Mangalavanam - Improvements to Marine Drive walkway:

Open space corridor linking project improvement is estimated at a cost of INR 6.50 Crores for phase I. Project includes surface paving, landscaping and providing street furniture such as benches, street lights, advertisement boards etc., developing boardwalks, repairing/ constructing storm water drainage trenches etc.

Assistance required from KMC:

Smart city Team requested KMC to share to share approval regarding opening of fences along the stretch at Rajendra maidan & Subhash Park, Subhash Park & Ernakulam boat jetty, Priyadarshini park.

Decision taken: Smart City Team to proceed with tendering as the project is good for public and to be tendered without any delay.

d) Open Air Theatre (OAT) at Fort Kochi:

Open Air Theatre designed for a capacity of 228 people with a built-up area of 385 sq.m. for the OAT along with additional landscaped areas, lighting and provision of green room to cater to the needs of the artists/ performers, along with toilets for an area of 48 sq.m. has been proposed in KMC's fort Kochi zonal office premises. KMC has been proposed as the office for managing the events, revenue collection and O&M. Smart city team mentioned that there is a small dilapidated building that needs to be demolished to build the proposed toilets. KMC agreed for the same.

Assistance required from KMC:

Smart city Team requested KMC to approve the OAT project and also confirmation regarding taking over O&M and revenue collection.

Decision taken: Smart City Team to proceed with tendering as the project is good for public and to be tendered without any delay.

Scope - Rainwater harvesting structures in 13 Govt buildings

A project for providing Rain Water Harvesting (RWH) Structures in 5000 households was identified under Kochi Smart City Proposal. In view of the delay in identification of beneficiaries under AMRUT, KMC proposed to implement Rain Water Harvesting for Government Buildings only under Smart City Mission as individual Households had already been taken up under AMRUT scheme. Under Smart City 39 Government buildings / offices falling under ABD area were identified. Site visits were conducted and discussions with concerned stakeholders and local councillors to understand the ground conditions, water table, recharge and storage requirements etc have taken place. Based on the study 13 buildings were finalised for provision of RWH structures. Further details such as requirement of water for cleaning, storage requirement, locations for storage tanks / recharge tanks and pipe /gutter requirements have been finalized. Among 13 buildings, storage tanks are proposed in 3 buildings. For remaining buildings recharge pits shall be constructed.

There are two options to do water harvesting in the project area. Current practice of adopting roof storm water harvesting is recommended as per Government of Kerala rules and regulations. Second option is providing water harvesting structures/pits in open ground available within building area so that storm water is collected in it to improve ground water levels. But limitation of this option is water table is just 1 m below the ground level in project area. But after analysing the existing situation, area it has been suggested to implement in the areas where bore water is in use and where enough land is available to construct harvesting structure.

Accordingly, the water harvesting structures have been proposed for 13 government buildings out of which 3 sites building water storage tanks have been proposed and 9 buildings Recharge pits and one building, pie connection is only have been proposed.

These buildings are: General Hospital, Ernakulam, Govt Girls High school, Mattancherry, Mattancherry Hospital, Law college, Ernakulam (2 nos), PWD Guest House, Ernakulam Fire station (2 nos), Court Building (2 nos), Maharaja College (2 nos), Fort Kochi Hospital, Corporation zonal office, Mattancherry (2 nos), Mattancherry Fire station (2 nos), Government Veterinary Hospital, KSHB building, Police Quarters, Mattancherry (3 nos)

Renaming of project with respect to scope change is placed for approval.

Scope - Sewerage System for West Kochi

The 2nd Technical Committee Meeting has been held on 20th December, 2018 and Executive Engineer, KWA, on behalf of committee, made a presentation on their experience and technical details s of vacuum system.

1. Networking:

All the committee members accepted the proposal of vacuum network system for collection of sewerage. The committee observed that the technology has several advantages over the conventional system. The committee observed the following key benefits of the system.

No leakage



- Minimal maintenance cost
- Low depth of excavation
- Can be implemented even along narrow roads

1. Sewage/Septage Treatment:

The committee enquired the status of land availability for treatment plant. The PMC listed the land availability details as below.

- a) Probable STP Locations
 - Vacant land near fort Kochi hospital (Area 45 Cents) ward 2 under the ownership of KMC
 - Mattancherry zonal office premises (20 cents Approx) ward 5 under the ownership of KMC.
- b) Pumping station locations
 - Veli ground (26 cents) ward 1
 - Thamarakkulam Park (10 cents) ward 1
 - Momens Park (22 cents) ward 3

The PMC informed the committee the reservations of KMC in allotting Mattancherry zonal office premises for the construction of STP.

2. Recommendations

- a) The ABD area in west Kochi may be divided into two zones, First with ward number 1, 2 and 3 and second with ward numbers 4 and 5. The ST plant for ward number 1,2 and 3 may be constructed in the vacant land near Fort Kochi hospital (in ward number 3). Treatment plant for ward number 4 and 5 may be constructed in the Mattancherry zonal office premises. The pumping station locations may be utilized as per design requirements.
- b) The committee recommended to tender network and plant as a single package in EPC mode. The committee also suggested to collect suitable technology from bidders which will suit into the space availability mentioned above with separate quote for different technologies. The suitable technology can be selected through technical presentation. The committee decided to limit the technologies to 3 or 4 as listed below.
 - Sequential bed bio reactor
 - Membrane bio reactor
 - Electrolytic treatment
 - Activated sludge process
- c) Committee suggested to prepare detailed estimates and DPR as per the directions
 of the committee at the earliest.

Module 3 NMT Roads and Pedestrianized areas

Scope – Access Roads

The existing internal roads are to be developed as Access roads between the smart roads for improved traffic flow within the ABD area. The scope of works in Access roads are mainly but not limited to upgradation of drainage facilities by construction of new drains, Irish drains and restoration of existing drains as per site requirements, provision of footpath (as per standards and space available) and surface improvement where ever required. Smart Roads: Construction, operation and maintenance of Smart Roads

CSML intends to develop 5 roads in Ernakulam central area (4.9 Km) and 5 Roads in west Kochi (3.2 Km) as smart roads. The scope of work includes developing the existing roads mentioned above by upgradation and augmentation of foot path, provision of cycle lanes, providing Road Markings, Street Furniture, Bus bays, Street Landscaping works, utility trenching/ducting works, Construction of new drains and restoration of existing drains as per site requirements, shifting of utilities to underground trenches, foundation for street light poles, monopoles and smart poles, installation of compact substations, individual connections through feeder pillars, smart elements and other Miscellaneous works along with operation maintenance of landscaping works.

2.1.1 SOLAR ROOFTOP PROJECT IMPLEMENTATION PROGRESS

Contractor mobilized 330 KW panels in the month of November 2018. Following to this BHEL started site feasibility study and other paper works in the month of December 2018. Contractor prepared structural drawings for installation 450 KW of solar panels and submitted to PMC for approval. Clearance for installation of Solar panels has been given to BHEL for 18 buildings including Court Complex. The total capacity of solar panels in these buildings is (690 + 40) KWp. PMC also verified the solar panels (314 KWp) supplied by BHEL for various sites. BHEL agreed to submit the drawing of each buildings complete in all respects. Module installation for 40 KWp at Govt. Hospital at Karuvelipady and for 60 KWp at PWD Guest house have been completed.

Fire station & General Hospital

Installation of 40 KWp solar panels at Fire station and 70 KWp at General Hospital have been completed. Approval awaited for the same from Inspector, Electricity Department

• High Court Complex

Work for installation of Solar panels at Court complex is under progress.

Pedestrianisation of Broadway Street for approx. 500m stretch.

As per the Smart City Proposal the project identified is 'Scale up of GH into a Super-specialty care centres'. However, what exact scaling up was required was not proposed. Thus, the nature of upgradation was identified by CSML & PMC in numerous meetings conducted with





KMC & DMO & GH team. The initial proposal for General hospital was a W & C ward. But as General Hospital did not have enough space for building a W&C ward which was established when Smart City team started further discussions for GH proposal. Hence again after numerous discussions with GH team & then KMC the proposal was revised as Cancer ward adjacent to the Proposed cancer block by INKEL. Smart city team had had many meetings regarding this change of scope with KMC. During a discussion regarding the cancer care unit, it came up that since INKEL is already doing a project in same compound they may be awarded the proposed Cancer ward work as well to ensure consistency & continuity of work and reduce any disruptions due to two different agencies working on same company & buildings.

Cancer Extension Block, General Hospital: Projects intends to provide a dedicated cancer specialty ward block as an annex to the Existing LINAC building. The Council has given approval for Cancer Extension Block, General Hospital project on 9th October, 2018. The LOA has been issued to INKEL for the construction of Cancel Extension Block, General Hospital

Out Patient & Admin block, Fort Kochi taluk Hospital & Out Patient & Admin block, Women & Child Hospital, Mattancherry: Projects intends to provide a dedicated Outpatient department with individual consultation rooms, waiting areas and administrative block. Concurrently e Health solution is being developed and implemented by state Health department which integrates all departments and government hospitals into an efficient Hospital Information and Management system. It's thus panned to upgrade the IT infrastructure of General Hospital under the smart city mission project. The Council has given approval for Cancer Extension Block, General Hospital project on 9th October 2018

The main objective of the project is to develop an updated detailed GIS Base map on a scale of 1:1,000 for the Project area. The preliminary interpreted map should be ground verified and the final map is to be prepared by incorporating the ground truth data. These detailed



maps consisting of the planimetric details, Plot boundaries micro level Land use and utility services underground utilities as available from line departments need to be generated by contact ground truth collection, updating of map and data linking.

Available data at CSML will be integrated with the Base Map in GIS during the survey preparation of base map. The data will be collected in proper field data sheet format. The base map prepared through on-screen digitization of imagery will be used for survey for the updating purpose and finalization of layer wise Base Map with the attributes.
